


## **Early Cumberland County**

- Originally created in 1760 from York county, which was the only county at that time.
  - Lincoln county created at the same time.
  - Included a much larger area.
  - Cumberland county at some time went up to the Canadian border.
- Eventually parts of Cumberland county went to other counties
  - To Oxford county (early 1800s)
  - To Androscoggin county in 1854
  - There was quite a bit of trading county land back and forth at various points
  - Parts of early Cumberland are now in Kennebec, Franklin, and Somerset counties

#### Purpose of Project

#### Create an Index of Volumes 1-25 of Cumberland County Deeds for the period 1760 – 1796

- Include grantor, grantee, location, date and record of deed, volume/page
- User-friendly, searchable CD
- To become a professional publication
- Special Publication of MGS, Greater Portland Chapter
- Facilitate deed research

#### Need for the Project

- Currently a researcher must borrow film from FHL or go to the courthouse to see if person is in index
- Actual deed books are small and hard to read
- Current Deed Index Covers Volumes 1-381, 1760-1870
  - Lists only names of 2 parties, vol., page grantor/grantee
- Need to look at 34 bound indexes to find names
- Don't know if it's the right person
- Must go to deed books for location, dates & other parties

- •Clearly identifies grantor and grantee
- •Includes grantors not in index (co-signing spouses, etc.)
- •Shows location of property and dates
- •Can sort by grantor, by grantee, by location, date, volume/page.
- •Sorting by Volume/page will show all parties on the deed!

- The index of Grantor & Grantee & Volume/Page created from the Index Book or from Microfilm
- Deeds are viewed in the deed books or film to identify location
- Deeds are viewed to identify date of signing and of record
- Data entered onto Form & then onto Excel spreadsheet

- •Grantor Edward Gilman signs name (in existing Index)
- •Grantor Phebe Gilman signs (Not indexed; she must be added in Phase II)
- •Date deed signed: 1762 (Added Phase II)
- •Date of record is on the next page (Added Phase II)

#### Phases of Project

- PILOT—Create index for Letters A and B showing volume and page numbers. Get kinks out of the process
- **PHASE I** —Create index of grantors for rest of alphabet
- PHASE II —Enter location, dates, extra grantors/ grantees onto forms
- PHASE III—Combine new information into spread sheets
- **PHASE IV** Proof reading

#### Logistics

- Need many volunteers—do as much as you like!
- Take charge of a Letter of the Alphabet
- Carol McCoy is the overall project leader
  - Please communicate with her about what you're working on, progress, issues, questions
  - Avoid duplicating work done by other teams
- There are forms for you to use on the web to handwrite the index (relevant to Vol. 1-25)
  - Data must be typed onto a pre-made Excel spread sheet.
  - Some may prefer to type directly into Excel.

#### **Cumberland County Courthouse**

- Phase I—view Index Books covering 1760-1870
  - Indexes are on first floor, open to public
- Phase II--view Deed Books for extra information
  - The Registrar will allow us to view the large old volumes!
  - Court staff must retrieve originals from the attic
  - Large books are easier to read than the small books.
- Parking meters are 75 cents an hour
- No cameras
- Entrance may be front or back—security check
- Can't plug in computers
